**Sub: Forwarding the college-wise details of students admitted to (i) BDS Course and uploaded by Dental Colleges on DCI portal for the academic session 2016-17 and (ii) MDS Courses uploaded by Dental Colleges on DCI portal for the academic session 2018-2019 to State Dental Councils so as to ensure and restrict the Registration of such students / to add the MDS Qualification by respective State Dental Councils.**

Sir/Madam,

I am directed to forward herewith college-wise details of students admitted to (i) BDS Course and uploaded by Dental Colleges on DCI portal for the academic session 2016-17 and (ii) MDS Courses uploaded by Dental Colleges on DCI portal for the academic session 2018-19 to State Dental Councils for perusal, ready reference and records so as to ensure and restrict the Registration only of such students who holds a recognised dental qualification and his / her name, with other details was uploaded on DCI Website. The list is subject to outcome of any writ petitions / suit / appeal / SLP or any other legal proceedings in respect of any student or categories of students, pending before any court of law.

2. The Dental Council of India has, however, made its best efforts to maintain and update the list of students but still some discrepancies or typographical error or bonafide mistake might have taken place in compiling the data / list. As such the details of students shall be subject to the records available with the Dental Council of India. In case any dispute or issue is raised with regard to the eligibility or inclusion of the name of such students in the list, the respective State Dental Councils shall detail the complete facts of the case to this Council and its decision thereon shall be final.

3. In view of the above, the Executive Committee of Dental council of India in its meeting held on 27.10.2021 in order to ensure and restrict the Registration of a student who have duly completed his / her Course from a recognised college and his / her details were duly uploaded on DCI Website, has decided to direct / ask all the State Dental Councils to register only those students whose name is included in the list attached herewith.

4. It is once again clarified that no candidate shall be registered by any State Dental Council unless and until such candidates holds a recognised dental qualification and his name was included in the lists and uploaded his other details on DCI Website.

5. This issues with the prior approval of the President, DCI in terms of the decision taken by the Executive Committee held on 27.10.2021
