Sir/Madam,

ऊपर उल्लेखित विषय पर संदर्भाधीन भारतीय दन्त परिषद के परिपत्रों के क्रम में, जिसके द्वारा सभी राज्य दंत परिषदों/न्यायाधिकरणों से अनुरोध किया गया था कि वे धारा 18(2) के तहत सभी मौजूदा पंजीकृत दंत चिकित्सकों के अद्यतन डेटा को सॉफ्ट कॉपी में प्रस्तुत करें, मुझे यह सूचित करने के लिए निर्देशित किया गया है कि अधिकांश राज्य दंत परिषद द्वारा अब तक आवश्यक जानकारी प्रस्तुत नहीं की गई है, जो कि अधिनियम, 1948 के अनुसार भारतीय दंत चिकित्सकों के रजिस्टर को बनाए रखने के लिए अनिवार्य है, जिसके प्रासंगिक भाग यहां पुनः प्रस्तुत किया जाता है:-

In continuation to DCI's circulars under reference on the subject cited above thereby requesting to all the State Dental Councils/Tribunals to furnish the up-to-date data of all the existing registered dentists in soft copy, as per Section 18(2) of Dentists Act, 1948 to maintain the Indian Dentists Register, I am directed to inform that most of the State Dental Councils have not so far furnished the requisite information, till date, which is mandatory as per the Act, the relevant portion is reproduced hereunder :-

"(2) Each State Council shall supply to the Council twenty printed copies of the State register as soon as may be after the 1st day of April of each year, and each Registrar shall inform the Council without delay of all additions to and other amendments in the State register."

2. उपरोक्त के मद्देनजर, फिर से यह अनुरोध किया जाता है कि आप अपने राज्य के सभी मौजूदा पंजीकृत दंत चिकित्सकों (भाग ए और भाग बी अलग से) के अद्यतन डेटा की सॉफ्ट कॉपी (एक्सेल फाइल.एक्सएलएस), संलग्न प्रारूप के अनुसार, रिकॉर्ड के लिए और भारतीय दंत परिषद की वेबसाइट पर अपलोड के लिए भेजे।

In view of the above, it is again requested to send/provide the up-to-date data of the all existing registered dentists (Part A and Part B separately) of your State Council, in soft copy (excel file.xls), in the enclosed format, for records as well as to enable this Council to update the same on DCI Website.
